

**ACCESSPHARMACY**  
**License Agreement (“License”)**  
**The McGraw-Hill Companies, Inc. (“McGraw-Hill”)**

**Definitions:** As used in this License, the following terms have the designated meanings:

“**AccessPharmacy**” refers to the online sites included as part of McGraw-Hill’s AccessPharmacy, including AccessPharmacy.com and any additional sites McGraw-Hill may designate as part of AccessPharmacy.
